Sri.Raghavan M M, SI has been sanctioned II Time Bound Higher Grade on completion of 18 years w.e.f 01.11.1998 in the scale of pay of Rs.7200-11400 and his pay is fixed at Rs. 7600/- w.e.f 01.11.1998.

He has opted to come over to the revised scale as per GO(P) 145/2006/Fin Dated.25.03.2006 w.e.f 01.11.2005 and his pay is fixed at Rs. 14750/- w.e.f 01.11.2005 in the scale of pay of Rs.11910-19350. After implementation of punishment awarded vide Order H2/PR/161/2002 DR dated 04/01/2002 of SP KKD(RL), Granted increment raising pay to Rs.15130/- w.e.f 01/11/2006 in the scale of pay of Rs.11910-19350.

The normal increment due on 01.11.2006 was not granted since he was awarded with the punishment of postponement of increment for one year with cumulative effect vide order No.H1/PR/4/2002/RL dated.12/06/2002 of Supdt.of Police Railways.

As per DGO No.2182/2020/PHQ Dated.09.12.2020,he was notionally promoted as Inspector of Police w.e.f 02.04.2007. Hence pay is fixed at Rs.15130/- w.e.f 02.04.2007 in the scale of pay of Rs.11910-19350.

He retired from service on 31/12/2007. In addition, the following punishments awarded to him which was not implemented at the time of his retirement.Hence , an amount of Rs. 18240/- (Rupees Eighteen Thousnad Two Hundred and Forty Only) being the unsuffered portion of increment bar has been recovered from his DCRG vide this office letter No. A3/37661/07DR Dated 17-08-2009

1. Postponement of increment for two years without cumulative effect vide order No.A2(b) 23/PR/2000 TSR dated.23.01.2004 of DIG, Thrissur range.
2. Postponement of increment for one year without cumulative effect vide order No.H2/PR/99 - 102/2003 dated.14.07.2004 of Supdt of Police, KKD(RL).
3. Postponement of increment for one year without cumulative effect vide order No. A2(a)/PR/12/2003 KR dated.29/10/2004 of DIG, Kannur Range, Kannur.
