In pursuance of the instructions there in the GOs cited, Sri. Gireesh Kumar , CPO-D 8964, PEN: 264342, Koyilandy Traffic Enforcement Unit of Kozhikode Rural District, who has completed 12 years of service, including basic training period and drawing a pay scale equal to that of Senior Civil Police Officers is designated as "Senior Civil Police Officer (Grade)" with immediate effect, subject to the conditions prescribed by Govt. in the integration of AR cadre with General executive cadre.

He will be promoted to the cadre of Senior Civil Police Officers as and when his turn comes in the regular line of promotion unless he is found ineligible. Senior Civil Police Officer(Grade) will be the personal rank of the person so designated. The person so designated will be eligible to wear the uniform of Senior Civil Police Officer. He will not be eligible for higher pay and allowances other than what would have been received if not been designated as Senior Civil Police Officer.

The regular CPOs so designated with Senior Civil Police Officer will be accommodated among the available sanctioned posts of the rank of CPOs till he attain regular promotion as Senior Civil Police Officer as per him cadre seniority. He will not be eligible to claim any seniority in the cadre of Senior Civil Police Officer on the basis of this designation. This order has retrospective effect with effect from the date of completion of 12 years of service including training period. All the conditions stipulated in the Government orders are applicable to the designated Grade SCPOs and he will be allowed to continue in the present Unit/Station. The General Number of Senior Civil Police Officers (Grade) should be quoted in all correspondences.
