In pursuance of the orders contained in the GOs cited,Sri. Dileep Kumar B, Bugler PC-D 11241, DHQ, Kozhikode Rural has completed 25 years of service, including basic training period and drawing a pay scale equal to that of Bugler Sub Inspectors is designated as Bugler Sub Inspector (Grade) with immediate effect subject to the conditions prescribed by Govt. in the integration of AR cadre with General Executive Cadre.

He will be promoted to the cadre of Bugler Sub Inspector as and when his turn comes in the regular line of promotion unless he is found ineligible. Bugler Sub Inspector (Grade) will be the personal rank of the person so designated. The person so designated will be eligible to wear the uniform of Bugler Sub Inspector of Police. He will not be eligible for higher pay and allowances other than what would have been received if not been designated as Bugler Sub Inspector of Police.

The regular Bugler PC/Bugler HC/Bugler ASI so designated with Bugler Sub Inspector will be accommodated among the available sanctioned posts of the rank of Bugler PC/Bugler HC/Bugler ASI of till he attain regular promotion as Bugler Sub Inspector as per him cadre seniority. He will not be eligible to claim any seniority in the cadre of Bugler Sub Inspector on the basis of this designation. This order has retrospective effect with effect from the date of completion of 25 years of service including training period. All the conditions stipulated in the Government orders are applicable to the designated Grade Bugler Sub Inspector and he will be allowed to continue in the present Unit/Station. The General Number of Grade Bugler Sub Inspector should be quoted in all correspondences.
