In pursuance of the orders contained in the GOs cited ,the following CPO DVR/SCPO DVR/ASI DVR of Kozhikode Rural District who have completed 25 years of service, including basic training period and drawing a pay scale equal to that of Sub Inspectors are designated as Sub Inspector DVR (Grade) with immediate effect subject to the conditions prescribed by Govt. in the integration of AR cadre with General Executive Cadre.

He will be promoted to the cadre of Sub Inspector DVR as and when their turn comes in the regular line of promotion unless they are found ineligible. Sub Inspector DVR (Grade) will be the personal rank of the person so designated. The person so designated will be eligible to wear the uniform of Sub Inspector of Police DVR. He will not be eligible for higher pay and allowances other than what would have been received if not been designated as Sub Inspector of Police DVR.

The regular CPO DVR/SCPO DVR/ASI DVR so designated with Sub Inspector will be accommodated among the available sanctioned posts of the rank of CPO DVR/SCPO DVR/ASI DVR of till they attain regular promotion as Sub Inspector DVR as per their cadre seniority. They will not be eligible to claim any seniority in the cadre of Sub Inspector DVR on the basis of this designation. This order has retrospective effect with effect from the date of completion of 25 years of service including training period. All the conditions stipulated in the Government orders are applicable to the designated Grade Sub Inspector DVR and he will be allowed to continue in the present Unit/Station. The General Number of Grade Sub Inspector DVR should be quoted in all correspondences.
