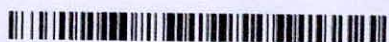
TENDER No.04/2022-23/W (Retendering)

A Tender had called for as per this office Tender Notice No.1 on 8/12/2021 and retender placed on 06/12/2022 for purchasing Analytical Weighing Balance with Density Determination Kit, but the items could not be procured due to price difference. The District Police Chief, Wayanad, Kerala Police Department, Government of Kerala invites Bids from reputed manufactures/authorised dealers or reputed vendors for the supply of Analytical Weighing Balance with Density Determination Kit. The Bidders should comply with the following general condition in addition to the additional conditions of the instant Tender.

GENERAL:

1. The Bidder should be a reputed Original Equipment Manufacturer (OEM) or having an Authorization Certificate from the OEM to participate in the tender floated by Kerala Police. Certificate from the OEM for sales and service, to be produced.
2. One bidder cannot represent two suppliers/OEMs or quoted on their behalf in a particular tender.
3. The OEM/Bidder should have a well-equipped service centre functioning in India (preferably in Kerala) to cater to immediately after sales requirements, a copy of Service Centre details must be enclosed along with the Tender document.
(Preferably bidder should have a Service Centre in Kerala/South India).
4. A reputed vendor can participate in the tender provided the vending outfit is functioning in the market for at least 5 years.
5. The Bidder should have valid GST registration. Copy of GST registration certificate should be enclosed along with the tender.
6. The bidder should have a valid PAN/Taxation Index Number. Copy of PAN/Taxation Index Number allocation letter should be enclosed along with the tender.
7. The Bidder must fulfill the following minimum qualification criteria to prove the techno-commercial competence and submit the documents in support thereof:

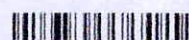
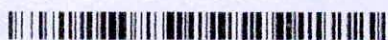
- Valid Authorisation letter from the OEM to attend this particular Tender. Certificate of Registration/Incorporation, Certificate of the Bidder.
- Last 3 years financial status of the Bidder's/P&L and Balance Sheet/audit report of the last 3 years.
- The Bidder (authorised dealer/distribution) should have the dealership/distributorship for the last 3 (three) continuous consecutive years with the OEM.



- The Bidder has to submit a letter specifying the warranty period. In case of propriety item, a certificate by the OEM to be attached.

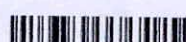
1. The Tender should be super scribed with Tender Number and name of the store item and to be addressed to The District Police Chief, Wayanad, Kalpetta(PO), Pin-673122, Kerala. Late Tenders will not be accepted.
2. **The tenders should be submitted in two separate parts containing Technical and financial bids in separate sealed envelopes clearly super scribed and should together in a large envelope, all envelopes sealed and super scribed with "Tender No. and name of item". If any offer contains technical bids and financial bids together in one envelope, such offers shall be rejected outright.**
3. Tenders of the offers received with requisite EMD or Bid Security will be opened on 16/02/2023 at 11 am in the presence of the authorized representatives of the firm



who may be present at that time. All tenders received without EMD will be rejected, outright. All prices quoted should be inclusive of all levies and taxes.

4. Earnest Money Deposit (EMD) should be furnished along with the Tender. EMD may be submitted either in crossed Bank Drafts/Treasury Savings Bank Deposits/Government Promissory Notes/Bank Guarantee or National Saving Certificates drawn in favour of the District Police, Chief, Wayanad District, Kalpetta(PO) PIN-673122, The name of the firm and Tender number should be mentioned in the reverse side of the EMD and Tender cost. Firms which are exempted from furnishing EMD should produce a copy of relevant authorized document for verification. Without EMD, the Tenders will be rejected.
5. Specifications and list items of each tender shall be obtainable from the District Police, Chief, Wayanad, Kaletta, Pin: 673122. during working hours of office. The firms should also furnish the detailed specifications, make brochures, Test Report from Govt. Laboratories/Agencies (wherever possible) technical support network in Kerala etc. of the equipments along with the tenders. The Tenders without detailed specifications of quoted items, Brochures, make etc. are liable to be rejected forthwith. The Tenders without separate envelope and not super scribing the Tender number will be rejected.
6. As the items are urgently required, the selected bidder will have to supply the item without loss of time, preferably within five days.
7. The rates quoted should be valid and firm for 180 days from the tender date.
8. The District Police Chief, Wayanad is empowered to reject any Tender without assigning any reason.
9. Any clarification/ doubts regarding the specification or related matters pertaining to the items tendered may be got cleared through E1 Section (04936- 202522/ 960574132) or Joint Director/ Asst. Director, Regional Forensic Science Laboratory, Kannur (doubts regarding the specification) Ph. No.9447202151 on all Government working days from 10:30 am to 5:00 pm.


16. Balance should supply along with density determination kit for both solids and liquids.

20. Suitable cover should be provided.
