As per the reference 1st cited, House Building Advance of **₹19,75,000/- (Rupees Nineteen Lakhs and Seventy Five Thousand Only)** was sanctioned to Sri. Rajeevan .M, CPO 9150 (PEN 143404) of Koyilandy PS of this unit. On Completion of the House Building Advance repayment in respect of Sri. Rajeevan. M, CPO 9150 (PEN143404) of Koyilandy P.S.; Office of the Accountant General calculated and intimated that the interest on HBA is ₹4,47,121/-. On the basis of this intimation vide reference read 3rd above; D.O. vide reference 4th cited was issued for the recovery of HBA interest from August 2023 for 28 installments.

Recovery of interest on HBA started from 08/2023 and an amount of ₹1,11,121/- was recovered from the salary up to 02/2024(6 installments - 16000 & 1 installment- 15121). Out of total Balance amount of ₹3,36,000/-; **an amount of ₹80,000/- shall be recovered from the salary from 03/24 to 07/2024 @16,000/-.**

Under the above circumstances, the remaining balance amount of **₹2,56,000/- (Rupees Two Lakh Fifty Six Thousand only)** should be recovered from the DCRG since the incumbent is going to voluntarily retire from the service on 31/07/2024.

Accordingly, this office D.O. cited 4th is modified to the above extent in view of the VRS to be taken on 31.07.2024 by the above mentioned incumbent.
