Sub : Police Estt: Formation of Cyber Police Division & Strengthening of Cyber Police Stations – Structure, functions and cadre strength of Cyber Police Division- Additional Strength added-Orders issued.

The increase in the number and complexity of Cyber Crimes has necessitated several steps that must be taken to equip the Police Department to effectively tackle it. In order to prevent and to effectively deal with Cyber Crimes, Government have formed a 'Cyber Police Division' in the State comprising of two wings namely 'Telecommunication and Technology and Cyber operations'.

As part of the formation of Cyber Police Division, The Government have accorded sanction to strengthen the Cyber Police Stations in districts. As such the following additional strength have been sanctioned in Cyber Police Station, Kozhikode Rural vide the PHQ order 3rd cited. The strength details as follows.

As per the PHQ order cited third the following instructions are also issued in connection with transfer and posting and administration control at Cyber Crime PS.

1. Posting of officers in the cadre of KCP to Cyber Crime police stations will be done by DPCs concerned and posting of loP to Cyber PS will be done from PHQ.
2. Posting of personnel from the Telecommunication and Technology unit to the entire Cyber Crime Police Stations will be done by IGP Cyber Operations.
3. The Civil/ Tele personnel posted to Cyber Crime police stations will be under the administrative control of the DPC. Their administrative matters will be processed in the District Police offices.
4. Police personnel posted to Cyber Crime PS, from telecommunication unit will hold their lien in parent cadre; all their service prospects will be based on their seniority in parent cadre.
