Sri.Reghu.K T, GSI (D 8790) Pen: 149688 was awarded with a punishment of increment bar for Two year with cumulative effect as per the reference 2nd cited (order No.H1/47597/2022/DR). But the same could not be implemented since he was retired from service on 28-02-23. The last increment was sanctioned to him w.e.f 01/01/2023 and his pay reached at Rs.75400/- in the scale of Rs.50200-105300

Sri.Reghu.K T, GSI (D 8790) Pen: 149688 was awarded with a punishment of increment bar for Two year with cumulative effect as per the reference 2nd cited (order No.H1/47597/2022/DR). But the same could not be implemented since he was retired from service on 28-02-23. The last increment was sanctioned to him w.e.f 01/01/2023 and his pay reached at Rs.75400/- in the scale of Rs.50200-105300.

In-order to implement the punishment of increment bar for Two year with cumulative effect the monetary value of un-suffered portion increment bar will be recovered from his DCRG.

Calculation of monetary value of un-suffered portion of punishment is as shown below.

Basic pay as on 01/01/2023 - 75400

Punishment awarded - Increment bar for 2 Years with cumulative

If he is in service, basic pay as on 01/01/2024 = 77200

If he is in service, basic pay as on 01/01/2025 = 79000

Increment rate for 1st year (77200 - 75400) = 1800

Increment rate for 2nd year (79000 - 77200) = 1800

I) Amount to be recovered as the monetary value for the 1st year (1800 x 24 x 3) = 1,29,600/-

II) Amount to be recovered as the monetary value for the 2nd year (1800 x 12 x 3) = 64800/-

TOTAL = 1,94,400/- (Rupees One lakh Ninety Four Thousand and Four Hundred Only)
