Sub : Revision of Probation in the cadre of CPO by treating the training period as duty -
Orders issued -Reg :

Ref : 1. GO (MS) No.179/2020/Home Dated. 24/09/2020.
2. PHQ Letter No. E8-122148/2020/PHQ Dated. 15-12-2021 and 18-02-2022.

The State Police Chief has directed to take necessary action to implement the GO(MS No.179/2020/Home, in the case of those who are appointed after 31-01-2011 and to revise the service benefits already given. In the PHQ letter dated.18-2-2022 referred above it was further instructed that the process should be done by the competent officer in present unit where the personnel concerned is working and it is the responsibility of the present unit head to implement the order.

Hence the orders regarding the declaration of probation in the cadre of Civil Police Officers of this unit have to be revised by treating the training period as duty. Previously their probation in the cadre of CPOs had already been declared after evaluating their work and conduct as shown in column No.5 and so, there is no need to re-evaluate the work and conduct of these CPOs when their probation order is revised by treating the training period as duty since the new date of declaration of probation comes before the previous date of declaration.

Hence the probation in the cadre of two Civil Police Officers of this unit is hereby revised by treating the training period as duty and declared to have completed their probation in the cadre of CPO Satisfactorily with effect from the date as shown in the column No.10.
