In pursuance of the orders contained in the GOs cited ,Sri. Anilkumar V.P, HC DVR D 7553 of DHQ, Kozhikode Rural who has completed 20 years of service, including basic training period and drawing a pay scale equal to that of ASI(GE) are designated as ASI DVR(Grade) with immediate effect subject to the conditions prescribed by Govt. in the integration of AR cadre with General Executive Cadre.

He will be promoted to the cadre of ASI DVR as and when his turn comes in the regular line of promotion unless he is found ineligible. Asst Sub Inspector of Police DVR(Grade) will be the personal rank of the persons so designated. The persons so designated will be eligible to wear the uniform of ASI DVR. He will not be eligible for higher pay and allowances other than what would have been received if not been designated as ASI DVR.

The regular SCPO DVR so designated with Grade as Asst Sub Inspector of Police DVR will be accommodated among the available sanctioned posts of the rank of CPO DVRs/SCPO DVRs till he attains regular promotion as ASI DVR as per his cadre seniority. He will not be eligible to claim any seniority in the cadre of ASI DVR on the basis of this designation. All the conditions stipulated in the Government orders are applicable to the designated Grade ASI DVRs and he will be allowed to continue in the present Unit/Station. The General Number of Grade ASI DVRs should be quoted in all correspondences.
