Sub : Sanctioning of Periodical increment to Sri. Jijilkumar, CPO D 10393 (PEN - 645153) after suspension-Orders issued.

Sri. Jijilkumar, CPO D 10393 (PEN - 645153) was drawing a pay of Rs.24600/- w.e.f 01/08/2017, Rs. 25200/- w.e.f 01/08/20218 and Rs.25850/- w.e.f 01/08/2019 in the SOP of Rs.22200-48000/- . As per the 11 th PRO his pay fixed as follows:

Pay fixed to Rs.35600/- w.e.f 01.07.2019 in the revised scale of Rs.31100-66800,granted increment raising pay to Rs.36500/- w.e.f 01.08.2019. On completion of 8 years Service sanctioned 1st Time Bound Higher Grade Rs.38300 /- w .e.f 22/09/2019 in the scale of Rs.35600-75400/-(UQ).

His increment was due on 01/08/2020 but he was suspended from 29.05.2020 to 22.09.2020(117 days) and this period of suspension is regularized and awarded increment bar for 2 yrs without CE and the period of suspension is treated as duty for pension and gratuity only vide reference 3rd cited. After excluding the suspension period from 29.05.2020 to 22.09.2020(117 days) he is sanctioned periodical increment raising pay to Rs. 39300/- w e f 25/11/2020 . His next increment due on 01/11/2021 and the same is postponed since he was awarded increment bar for 2 yrs without CE . After the implementation of punishment he is granted increment raising pay to Rs. 40300/- w.e.f 01/11/2021 and to Rs.41300/-w.e.f 01/11/2022(both M.B from 01/11/2023).

He is granted increment raising pay to Rs.42300/- w.e.f 01/11/2023, Rs.43400/- w.e.f 01/11/2024. Next increment due on 01/11/2025.

Hence this office DO Vide reference cited 2nd is modified to this extend.
