The Government has issued an order to create 304 posts in the Police Department to form a Special Investigation Team to investigate POCSO cases, vide GO cited 1 st. Accordingly, for the effective investigation of POCSO cases, the existing DySP posts in the Narcotics Cells of 16 police districts were renamed as "Dy.SP Narcotic Cell & Gender Justice" and given additional responsibilities, vide GO cited 2nd. As per GO cited 3rd, sanction is accorded to create 2 Sub Inspector of Police, 2 Assistant Sub Inspector of Police, 6 SCPO and 5 CPO to form a Special Investigation Team.

As such **DySP Narcotic Cell, Kozhikode Rural** is renamed as **"DySP Narcotic Cell & Gender Justice", Kozhikode Rural**.

2 Sub Inspector of Police (KCP), 2 Assistant Sub Inspector of Police (KCP), 6 SCPO (KCP) and 5 CPO (KCP) were additionally allotted to Kozhikode Rural Sanctioned strength and the allotted Strength of Kozhikode Rural Police district has been enhanced .

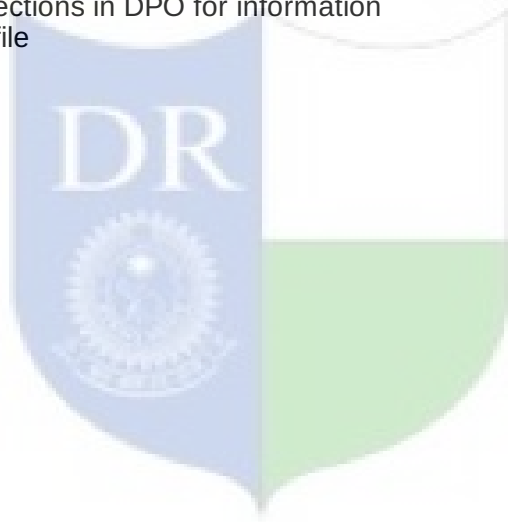
