As per the reference 1st and 2nd cited, it is clarified that the Police Constable Drivers are not included in the Special Rules notified vide GO(P) No.6/84 Home dated.10.01.1984 and hence they are not eligible for the 4th Time Bound Higher Grade on completion of 27 years of qualifying service in the entry post. The Police Constable Driver category are eligible for 4th Time bond Higher Grade after 1/4/2021 only.

In pursuance of the direction vide reference 3rd & 4th cited, on scrutiny of the Service Book in r/o Sri.Sasi S P, Dvr SI D 6128, DHQ Kozhikode Rural, it was found that he was erroneously granted 4 th Time Bound Higher Grade w.e.f 02.08.2020. Hence the 4th Time Bound Higher Grade sanctioned to him vide this Office DO No.468/2020 DR dtd 16.09.2020 is hereby cancelled and his pay is retained at Rs.68400/- w.e.f 01/08/2020 in the scale of Rs.45600-95600.

As per the reference 1st and 2nd cited, the Police Constable Driver category are eligible for 4th Time bond Higher Grade after 1/4/2021 only. Hence on completion of 27 years of qualifying service, Sri.Sasi S P, Dvr SI D 6128, Pen:145638, DHQ Kozhikode Rural, is granted fourth Time Bound Higher Grade, and pay fixed as shown below.
