In pursuance of the instructions there in the GOs cited ,Sri. Sreejith P.K D 6946, of Payyoli Police Station, Kozhikode Rural, have completed 25 years of service, including basic training period and drawing a pay scale equal to that of Sub Inspector is designated as Sub Inspectors(Grade) with immediate effect subject to the conditions prescribed by Govt. in the integration of AR cadre with General Executive Cadre.

He will be promoted to the cadre of Sub Inspectors as and when his turn comes in the regular line of promotion unless he is found ineligible. Sub Inspector(Grade) will be the personal rank of the person so designated. The person so designated will be eligible to wear the uniform of Sub Inspector of Police. He will not be eligible for higher pay and allowances other than what would have been received if not been designated as Sub Inspector of Police.

The regular CPOs/SCPOs/ASIs so designated with Sub Inspector will be accommodated among the available sanctioned posts of the rank of CPOs/SCPOs/ASIs of till he attain regular promotion as Sub Inspector as per him cadre seniority. He will not be eligible to claim any seniority in the cadre of Sub Inspectors on the basis of this designation. This order has retrospective effect with effect from the date of completion of 25 years of service including training period. All the conditions stipulated in the Government orders are applicable to the designated Grade Sub Inspectors and he will be allowed to continue in the present Unit/Station. The General Number of Grade Sub Inspectors should be quoted in all correspondences.
