As per the Common Order of Hon'ble Kerala Administrative Tribunal dated 27/06/2022 in OA.2171/2019 and connected O.A's. Government have issued fresh order to grant Second Time Bound Higher Grade which became due prior to 2001 to the technical Police personnel in the scale of Sub Inspector of Police on condition that **arrears on account of pay will be notional**. Hence the pay in respect of S Sri.Karunakaran K P, Retired HC 5778 (Tailor) (PEN - 521690) is revised and re-fixed as follows.

He has entered in service on 12-09-1985 ( Date of Completion of Training on 14.03.1986). On completion of 15 years of qualifying service, sanctioned 2nd Time Bound Higher Grade at Rs.4500/- w.e.f 14.03.2001 in the scale of pay of Rs.4500-7000.

As per GO(MS) No.1224/2000(84)/Fin Dt.16-10-2000, the pay Scale of SI of Police is modified as Rs.5500-9075 w.e.f 16-10-2000. Hence sanctioned 2nd Time Bound Higher Grade at Rs.5500/- w.e.f 14.03.2001 in the scale of pay of Rs.5500-9075.


