Pay reached at Rs. 46900/- w.e.f 01.06.2019 in the scale of pay of Rs.32300-68700. Granted increment raising pay to Rs.48000/- w.e.f 01.06.2020. As per GO(P) 27/2021 Fin dtd 10/02/2021, his pay revised at Rs.65200/- w.e.f 01/07/2019 in the scale of pay of Rs.45600-95600. Granted increment raising pay to Rs.66800/- w.e.f 01.06.2020.

As per the Govt letter cited 1st and PHQ letter cited 2nd, it is clarified that prior to 01.04.2021 (date of effect of TBHG as per 11th Pay Revision Order), Police Constables including Civil Police Officer only are eligible for the 4th Time Bound Higher Grade and after 01.04.2021 Police Constable Driver category is also included under the ambit of 4th Time Bound Higher Grade. It was also directed to cancel the irregular higher grades sanctioned and take urgent necessary steps to recover the excess amount drawn. Under the above circumstances, the 4th Time Bound Higher Grade sanctioned is cancelled vide reference 3rd cited and excess drawn amount of Rs.27456/- (Twenty Seven Thousand Four Hundred and Fifty Six) has been remitted to the Sub Treasury Vatakara vide Challan No.KL 0272 0958 120 2122 M Dated.30.03.2022. Hence on completion of 27 years of service, sanctioned 4th Time Bound Higher Grade and pay fixed as follows.
