Sub : Treating the training period as duty in the category of Civil Police Officer- Monetary benefit of 2nd periodical increment revised - Orders issued reg:-

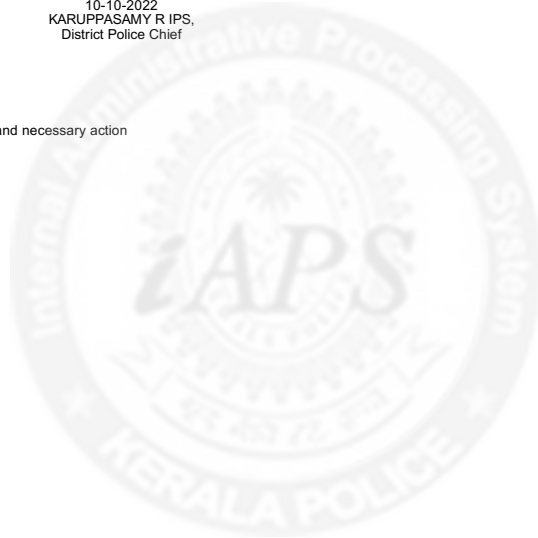
